# Notes of site meeting at Creedy View 9<sup>th</sup> October, 2020 at 14.30 hrs. Present:

Margaret Squires – MDDC + DCC Mike Snow - SPC Brian Fife- SPC Elizabeth Dalton- SPC Gordon Griffin- SPC Shuana Miles- SPCA Dave Hope- SPC Jim Steven- SPC Steve- SPC Adrian Devereaux – MDDC Planning Officer.

AD introduced how MDDC have to make an assessment on all issues, based on their policies. MS – raised the issue of sewerage capacity being up to capacity 20 years ago and it is now a real issue. ESD added she frequently walked passed the facility and the warning light was 95% on red. BF – mentioned his understanding of layout and queried on-site attenuation of surface water only, asserting this was a very significant issue.

ESD – mentioned that MDDC owned a cut-through strip of land from Brady Close giving an alternative access to the proposed site and asked if this had been considered.

AD - Referred to charging points as referred to in the Local Plan.

MS - said more than 2/3 points

BF – queried if this complied with requirement of the Local Plan.

MDDC – said it would be within adopted policies.

DH - queried if this ensures electric cars?

BF - mentioned that from 2030 there will be no further manufacture of petrol cars.

MS – suggest looking towards Western Power, who wants £14,000 to upgrade their connection.

JS – Queried the affordable housing of 30% policy and would this be met.

MDDC - said this applied only to new sites. (Is this not a new site).

GG – queried 'what is the definition of Affordable housing.

MS – some buy some rent, e.g. Pedlars Pool.

JS – stated we want more connectivity between Meadowside and being able to access the school without using roads, e.g. following the existing footpath behind Creedy View NO. 4.

AM – suggested they could improve the footpath, given 20 years ROW use and away from road. JS – queried who would be responsible for the HaHa maintenance. He reiterated No. 1 Creedy View has great concerns about the number of dwellings being applied for. The developer will take the view into account and is proposing to build bungalows at the end??

ESD – queried whether, or not, 3-storey dwellings would be allowed.

JS – queried how many affordable dwellings and mixed were to be allowed.

There followed a walk down the site to look at the end of the path, joining Meadowside and the large drop down in height. Discussion followed on how this could be made available to the disabled.

JS - GG – asked that planning could link the footpath with the proposed link to Pedlars Pool that was being organised by Sandford Parish Council.

JS – mentioned mixed housing and an obligation to upgrade the play area.

ESD – added that SPC were also looking to install an outdoor gym to give some facilities for the adolescent members of Sandford.

MD – suggested this could be part of the S106 monies use.
